### Audit

#### Financial and tax audit

This Audit is a Handy instrument for different levels of your team and different purposes, such as investment, credit, and compliance with legal and tax obligations, among others, as well as for compliance with the fiscal opinion (SIPRED) in case of being obliged.

#### Social Security and INFONAVIT audit

This service aims to ensure that companies comply with the obligations established by law regarding Social Security and INFONAVIT in Mexico. This audit is performed to identify any possible differences or defaults in payment fees, withholdings, contributions, and other obligations related to the Mexican Social Security Institute [IMSS] and INFONAVIT.

It is worth noting that if your company has more than 300 workers, filing an IMSS opinion is mandatory. The INFONAVIT opinion is optional; however, filing it has benefits, such as avoiding a government audit.

#### State tax audit

We carry out an audit on state taxes in which we review the proper compliance with the tax payment before the different state instances since, in some states, these opinions are mandatory.

#### First adoption of IFRS

We can assist you in performing an analysis and correctly applying the International Financial Reporting Standards, [in Spanish: las Normas Internacionales de Información Financiera] (IFRS), when they are adopted, as per the IFRS 1.

#### Preparation for financial and fiscal audit

#### Internal control over SOX financial information

### Due Diligence – Financial/Accounting, Tax, Social Security for M&A and financing transactions.

#### Carve-out and proforma financial statements
