Export Documentation Requirements

DB Schenker will assist you where permitted by law in the preparation of all documents to speedily and effectively move your shipments. We maintain one of the highest number of Licensed Customs Brokers in our industry, as well as a staff of highly qualified Entry Technician Specialists throughout Mexico as well as our offices worldwide. At your request, Customs clearance, including pre-clearance, may be available both at origin and destination. By the time shipments arrive in many countries, they are already pre-cleared.

Importing to Mexico

Import Services

DB Schenker can handle all import procedures in Mexico, including Customs clearance for air and ocean freight.

We can assist with Customs clearance procedures and operate regular consolidations to and from major cities worldwide.

We also offer airfreight service between the port of entry and other major airport destinations in Mexico once the shipment has been cleared by Customs.

Our import process is highly automated with documentation transferred to brokers immediately upon availability.

Shipments are tracked online giving advance warning of

their imminent arrival. A variety of management reports are available upon request.

Import Documentation Requirements

We will expedite imports into the country by ensuring that correct documentation accompanies each shipment. We need the following documentation to ensure speedy customs clearance: Commercial Invoice, Packing List, Certificate of Origin, Import Permit (from consignee for shipments.)

Note: For shipments to Mexico, it is recommended that a Spanish translation of all documents, including the labels, accompany the shipment.

Other Services
