





Importation alternatives in Mexico




Definitive Imports



- Mexican customer assigns its own customs broker and is responsible for the importation.
- Material is processed and stored at AP.
- AP services are billed at 16% VAT.
- Every purchase of goods or services in Mexico generates 16% Value Added Tax; this tax is a cash flow for Mexican companies, but it may represent a cost for foreign
- Steel Mill/Service Center keeps material ownership.

Temporary Imports



- Acero Prime is the importer of record and assigns its customs broker. Necessary Documents: Proforma Invoice, Certificate of Origin, Mill Test Report.
- Material is processed and stored at AP.
- AP services are billed at 0% VAT and customer may also access to preferential duties.
- Only 2 pedimentos has to be done per month: V1-Export pedimento by Acero Prime; V1-Import pedimento by the stamper or OEM.
- Steel Mill/Service Center keeps material ownership.

Some advantages of Temporary Importation

- Certified companies do not pay duties and taxes upon importation.
- Services provided within Mexico by an IMMEX company may not be subject to VAT 16%.

Agile customs clearance versus the Automatic Notice permit required.

 Up to 18 months to keep inventory under temporary importation IMMEX without paying for importation taxes.


